# English as an Additional Language (EAL) Policy



At Bridgewater our policies are regularly reviewed. This reflects current practice within school and all related government guidance and statutory requirements.

#### 1 Introduction

- **1.1** In our school the teaching and learning, achievements, attitudes and well-being of all our children are important. We encourage all our children to achieve the highest possible standards. We do this through taking account of each child's life experiences and needs.
- **1.2** A number of our children have particular learning and assessment requirements, which are linked to their progress in learning English as an additional language.
- **1.3** Children who are learning English as an additional language have skills and knowledge about language similar to monolingual English-speaking children, research also shows that it can exceed that of monolingual children. Their ability to participate in the full curriculum may be in advance of their communicative skills in English.

# 2 Aims and objectives

- **2.1** The National Curriculum secures entitlement for all children to a number of areas of learning and gives them the opportunity to develop the knowledge, understanding, skills and attitudes that are necessary for their self-fulfilment and development as responsible citizens. We promote the principles of fairness and justice for all through the education that we provide in our school.
- **2.2** The aim of this policy is to help ensure that we meet the full range of needs of those children who are learning English as an additional language. This is in line with the requirements of current legislation.

### 3 Teaching and learning style

- **3.1** In our school teachers take action to help children who are learning English as an additional language by various means:
- **3.1a** developing their spoken and written English by:
  - ensuring that vocabulary work covers the technical as well as the everyday meaning of key words, metaphors and idioms;
  - explaining how speaking and writing in English are structured for different purposes across a range of subjects;
  - providing a range of reading materials that highlight the different ways in which English is used;
  - ensuring that there are effective opportunities for talking, and that talking is used to support writing;

- encouraging children to transfer their knowledge, skills and understanding of one language to another;
- building on children's experiences of language at home and in the wider community, so that their developing uses of English and other languages support one another;

**3.1b** ensuring access to the curriculum and to assessment by:

- providing accessible texts and materials that suit children's ages and levels of learning;
- providing support through ICT, video or audio materials, dictionaries and translators, readers and amanuenses (writers/scribes);
- using the home or first language where appropriate and available.

#### 4 Curriculum access

- **4.1** All children in our school follow the curricular requirements of the Foundation Stage and the National Curriculum. Children with English as an additional language do not produce separate work.
- **4.2** The EAL language support teacher works in partnership with class teachers three days a week within and without the classrooms. This involves supporting individual children or small groups of children.
- **4.3** In the Foundation Stage we plan opportunities for children to develop their English, and we provide support to help them take part in activities.
- **4.4** The Foundation Stage helps children learning English as an additional language by:
  - building on children's experiences of language at home and in the wider community, so that their developing uses of English and of other languages support one another;
  - providing a range of opportunities for children to engage in speaking and listening activities in English with peers and adults;
  - providing some resources reading books etc.
  - providing a variety of writing in the children's home language as well as in English;
  - providing opportunities for children to hear their home languages as well as English whenever possible.

### 5 Assessment

- **5.1** Our EAL language support teacher assesses new EAL admits on entry. We carry out ongoing recording of attainment and progress in line with agreed school procedures.
- **5.2** The statutory assessment arrangements of the National Curriculum allow us to make special arrangements for children who are learning English as an additional language.
- **5.3** In the mathematics tasks and tests at Key Stage 1, we translate words or phrases that appear in the assessment materials or that the children use in their responses.

- **5.4** For the science and written mathematics test at Key Stage 2, we provide oral or written translations of words or phrases in the test papers which we think are likely to prove difficult for children for whom English is an additional language.
- **5.5** For the mental arithmetic test at Key Stage 2, we provide an oral translation of the test to children who have limited English.
- **5.6** The language support teacher may offer support to children during the Key Stage 1 and Key Stage 2 assessment period.

## 6 Remote learning

- **6.1** Whilst children are isolating or remote learning, teachers ensure that work and activities are set which match the children's ability and level of English so they can be successful in completing the work.
- **6.2** Our EAL language support teacher is available to provide support to staff when setting online work, or to remotely support EAL children/groups of children where appropriate.
- **6.3** Class Dojo, which has a 'translate' option, is used to communicate with parents/children meaning that messages can be translated into home languages, ensuring that all parents/carers are receiving and understanding them.
